Thank you for the email below clarifying the situation with regards to the tonnage exceedance. As within my previous email below it would be useful at this stage for a few more details as was set out in my earlier email. Although the quantity of material accepted is now below what was previously calculated, information regarding this exceedance is still going to be required.

*'Justification will need to be provided to explain the reasons behind the non-compliance(s). This should include (but not be limited to) details as to why this much extra material was used, how it was used, for what purpose, where it was used etc. You should also consider reviewing previously submitted drawings and plans for the site with a comparison as to how these may have changed as a result of the increase in material. You should also review all other aspects of the permit and waste recovery plan to identify if any additional breaches have taken place if any are identified – justification will need to be provided.'*

At this stage I don't think too much detail is required a summary would be fine, although further detail may be required within the actual surrender documentation but something for me to review would be appreciated.

Many thanks for the waste returns.

Following a review of these, we identified a figure on the Q1-2015 return which was significantly different to the other figures recorded for the import for haul road construction; the figure was recorded as being 7,340 tonnes. We have spoken to the operator and requested that they review their transfer notes and other relevant documents to confirm if this was correct. It has been confirmed by the operator that the figure of 7,340 tonnes appears to have been a typographical error, with the actual figure being 7.34 tonnes according to the relevant transfer notes.

Carrying this figure forward, we would therefore calculate the actual imported tonnage to be 32,469.75 tonnes. Whilst this is still above the approximate tonnage of 31,142 tonnes quoted in Section 2.2 of the Waste Recovery Plan (October 2012) submitted for the permit application, it reduces the exceedance from around 8,500 tonnes to (approximately) 1,327.75 tonnes.

As such, we would welcome NRW's thoughts on this and any available advice with regards to progressing the permit surrender process accordingly given the details listed above.

Regarding the surrender of permit EAWML 104868 / EPR/MB3232AP (use of waste for construction) at Nant Newydd Quarry.

As a result of the exceedance of the permitted waste limit by over 8,500 tonnes of material, the application will not be eligible for basic surrender. Under basic surrender full compliance of permit conditions must have been achieved. Due to this increase in waste accepted onto site, deviations from the waste recovery plan (specifically section 3.4) dated October 2012 incorporated into the permit under condition 2.1.1 have taken place.

A low risk surrender may be considered, however before we can advise on if a low risk surrender is appropriate of if a standard surrender application will need to be submitted further information is required.

Justification will need to be provided to explain the reasons behind the non-compliance(s). This should include (but not be limited to) details as to why this much extra material was used, how it was used, for what purpose, where it was used etc. You should also consider reviewing previously submitted drawings and plans for the site with a comparison as to how these may have changed as a result of the increase in material. You should also review all other aspects of the permit and waste recovery plan to identify if any additional breaches have taken place if any are identified – justification will need to be provided.

It is also likely that a revised waste recovery plan will need to be submitted in light of the extra material accepted on to the site. The waste recovery plan dated October 2012 was assessed based on specific information provided – this has now changed. Once submitted the document can be reviewed by our permitting teams who can advise on the recovery/disposal aspect factoring in the additional information.

Following the submission and review of this information we may then be in a position to advise on the surrender application required.

## **1.0 Background**

Egniol Environmental Ltd. (Egniol) were commissioned by WJ Owen & Son Ltd. (WJO) (the Operator) to facilitate the surrender of EPR Permit reference MB3232AP – Use of Wastes in Construction for WJO's Nant Newydd Quarry (the site), near Brynteg, Isle of Anglesey.

This permit (determined on 9<sup>th</sup> October 2013) allowed for the import to and processing of inert wastes on the site for use in the construction of a haul road along the eastern perimeter of the site. The purpose of constructing a haul road within this area was to allow for the access and extraction of virgin limestone under the route of the existing haul road, which passed along the central portion of site.

The permit application was based around the Standard Rules 2010 No.7 Permit (*Use of Waste in Construction*) with an additional site specific risk assessment undertaken due to the site being within 500m of the Cors Erddreiniog SSSI/RAMSAR/European Site; the permit was therefore classed as a bespoke permit.

As part of the application for a permit to carry out the above activities, a Waste Recovery Plan was compiled by Egniol on behalf of the Operator (reference: *Nant Newydd Quarry, Brynteg, Waste Recovery Plan, October 2012*). This document detailed the proposed activities in relation to the five key questions contained in Section 4 of Environment Agency Regulatory Guidance Note 13 "*Defining was recovery – permanent deposit of waste on land*".

This document serves to summarise works undertaken for the initial stages of the permit surrender process to date and provide supplementary information regarding the permitted activities and the proposed surrender of EPR Permit reference MB3232AP.

## **2.0 Material Volume Calculations**

Within the Waste Recovery Plan, a figure of 17,291.28m<sup>3</sup> was estimated as the volume of material required to construct the haul road at the location shown on the proposal drawings. This figure was derived by way of taking sections through the proposed haul road and calculating the difference in area between the existing quarry wall profile and the proposed haul road profile with this then being multiplied by the effective length of the section to give an estimated volume.

An assumed density of 1.8 tonnes per cubic metre was then applied to the estimated volume, resulting in an approximate weight of 31,124.304 tonnes of material required to construct the haul road to the proposed profiles as shown on drawing references 4706.HRD.01 and 4706.SEC.01, as enclosed in the previously referenced Waste Recovery Plan.

It should be noted that the density of the material used was assumed to be 1.8 tonnes per cubic metre and that the final figure of 31,124.304 tonnes (as listed within EPR Permit reference MB3232AP) was an estimate based on the assumptions as described above.

### **3.0 Permit Surrender Process**

#### **3.1 Initial Site Meeting**

Following a request from WJO to undertake the surrender process for Permit Reference MB3232AP, initial guidance was sought by Egniol from Natural Resources Wales (NRW) to confirm if the surrender would be classified as a Basic Surrender, Low Risk Surrender or Normal Surrender, in accordance with *Environment Agency Regulatory Guidance Note RGN9: Surrender*.

A meeting was held on site on 14<sup>th</sup> January 2016 between WJO, NRW and Egniol representatives to allow NRW to view the constructed haul road and conduct a site walkover of the area in question. Following the site meeting, NRW requested copies of outstanding Waste Returns for the period covered by the permitted activities (October 2013 to December 2015, inclusive); these were subsequently supplied to NRW by WJO.

#### **3.2 Waste Return Review**

NRW's review of the total incoming waste during the period of permitted activities produced a final figure of 39,801.41 tonnes; some 8,678.41 tonnes greater than the volume listed within the Waste Recovery Plan.

NRW subsequently requested further information to be provided to explain the differences between the two figures.

Egniol undertook a review of the waste return data for the period of permitted activities and identified a figure contained within the Quarter 1 – 2015 (January to March 2015) waste return, recorded as 7,340 tonnes. This was significantly higher than other incoming tonnage figures from the import period. Egniol requested WJO to review their individual Waste Transfer Notes (WTN) for Quarter 1 – 2015 to confirm if the figure of 7,340 tonnes was correct.

Following their review, WJO confirmed that the figure was a typographical error and that the figure should have been recorded as 7.34 tonnes, as evidenced by their WTN for the material load in question.

The reduced figure of 7.34 tonnes was corrected in the waste returns for the permit period, giving a final total imported tonnage of 32,469.75 tonnes, 1,345.75 tonnes above the volume listed in the Waste Recovery Plan and Permit reference MB3232AP. This was relayed to NRW by Egniol via email (dated 21/04/2016); NRW stated that additional information would be required to justify the increase to the permitted tonnages.

Initially, Egniol rechecked the proposed figures included within the Waste Recovery Plan; these were found to be correct based upon the proposed location and profile of the haul road included within the Waste Recovery Plan and as shown on drawing references 4706.HRD.01 and 4706.SEC.01.

### 3.3 Material Use

As part of this review process, it has been confirmed with WJO that all material imported to site under the permit reference MB3232AP during the period of permitted activities was utilised within the construction of the haul road along the eastern boundary of the site.

Additionally, as evidence by the WTNs and Waste Returns, all material imported to site was defined as being within the categories allowed within the Permit; the majority of this material was classed as "Soil and Rubble" with the Waste Catalogue code of 17.05.04 applied (*Soils and Stones*).

### 3.4 Justification of Imported Tonnages

As part of the process, and as requested by NRW, further information was collated relating to the tonnage of materials imported to site during the period of permitted activities and their usage.

A topographical survey was carried out on the haul road by Egniol on 17<sup>th</sup> May 2016 to record the levels and profiles of the haul road and supporting embankment. The data from the topographical survey was compared to the existing quarry face survey (undertaken at a previous time), with the volume of the constructed road and supporting slope calculated in cubic metres.

The total volume of material used to form the road and supporting slopes was calculated from the 3D surveys (dated 17<sup>th</sup> May 2016) as being 18,048.383m<sup>3</sup>; 757.103m<sup>3</sup> above the estimated value listed in the Waste Recovery Plan.

#### *Discussion*

Comparing the volume of 18,048m<sup>3</sup>, calculated in Section 3.4, with the Waste Return weight of 32,470t, this provides an actual density of material imported to site of 1.8t/m<sup>3</sup> which is precisely the figure assumed in the Waste Recovery Plan (WRP). This comparison provides good evidence that all of the material imported to site was placed in the construction of the haul road.

The small increase in volume of 757m<sup>3</sup> required to construct the haul road to the designed levels is probably down to three factors these being:

1. Additional material necessary to fill void created at the base of the quarry due to mineral extraction taking place between the date of the topographic survey and the start of the haul road construction;
2. Slight realignment of the haul road at the northern end;
3. Variances between the survey of quarry wall and the actual profile due to survey limitations.

This slight increase in volume is not considered to be a material difference to the volume contained in the WRP, especially as the additional material was used to avoid the sterilisation of primary mineral which was the principal upon which the WRP was approved.

### **3.5 Conclusions**

From the data sets discussed above and the surveys conducted on site allowing estimation of the tonnage of material physically present, it can be concluded that all of the material brought onto site under Permit Reference MB3232AP (32,469.75 tonnes as evidence by the Waste Returns provided previously by WJO) has been utilised in the construction of the haul road and supporting embankment.

Whilst this figure is 1,345.75 tonnes above that listed within the permit, this additional fill was necessary to ensure that the haul road was constructed to the design levels and that the road and supporting embankment were constructed to profiles which were sufficiently safe to allow site operations to continue within this area of site. The need for the additional fill was primarily as a consequence of needing to fill the void created by further virgin mineral having been removed from the base of the quarry between the surveys being carried out and work commencing on the haul road construction.

The haul road was also constructed slightly to the east of the design location at the northern end (within the Waste Recovery Plan) as a consequence of this extra extraction of virgin mineral.

### **3.6 Further Correspondence**

The figures discussed in Section 3.4 were relayed to NRW via email (dated 23<sup>rd</sup> May 2016) and as enclosed in Appendix 1) along with a copy of report summarising the surrender process to that point. NRW responded on 31<sup>st</sup> May 2016 confirming that the process could proceed as a Basic Surrender.
