LF drove a 4x4 around the site, GJ passenger.

Initially, took right hand fork and drove up to view tipping area.

Then onto view dewatering bay (under construction).

Then onto LTP to view lagoons and storage tank.

Then drove down towards sheds, enroute discussed final profile of site.

Continued down to sheds (2 of) to view operations and stored materials.

Retraced track and went down left hand fork to view tipping area from same contour level.
