WASTE DISPOSAL LICENCE

LANDFILL AT B.P. CHEMICALS LIMITED, BAGLAN BAY WORKS, PORT TALBOT

CONDITIONS ATTACHED TO LICENCE NO. 2/90

1. Only construction and building spoil together with furnace brickwork will be deposited.
2. No toxic waste to be deposited.
3. A control office will be maintained and permission must be obtained from the responsible person prior to any tipping of individual loads.
4. Temporary fencing must be provided around each site boundary, in order to define tipping area.
5. Solid waste shall be compacted and formed into layers as soon as possible after deposit and subsequently covered with suitable non-putrescible material.
6. No waste material shall be burned within the boundaries of the tipping site, and a fire on the site shall be regarded as an emergency and immediate action taken to extinguish it.
7. A record shall be kept of types of waste and quantities of waste deposited, but for normal material quarterly statements will be acceptable.
