B.P. CHEMICALS LIMITED, BAGLAN BAY  
PORT TALBOT

CONDITIONS ATTACHED TO LICENCE:

1. The average daily intake of waste will be a maximum of (20) tons.
2. No toxic waste to be deposited.
3. Only those wastes declared in the disposal licence application will be committed to be deposited and any changes be reported to the Waste Disposal Authority.
4. ~~The~~ existing control office shall be maintained at the site entrance.
5. ✓ A site identification board of durable material and finish shall be displayed at the entrance to the tip site, showing the name and telephone number of the person in charge of the site and the name of the Waste Disposal Authority, issuing the licence.
6. ✓ If any equipment is stored at the site, suitable facilities must be provided.
7. The site must be adequately fenced with gates at the entrance.
8. The site must be provided with adequate lighting during the hours of darkness.
9. The site must be adequately manned and supervised during working hours.
10. Solid waste shall be compacted and formed into layers as soon as possible after deposit, and not later than at the end of the working day on which the waste is received, and subsequently covered with suitable non-putrescible material.
11. No waste material shall be burned within the boundaries of the site and a fire at the site shall be regarded as an emergency and immediate action shall be taken to extinguish it.
12. All major outbreaks of fire should be notified to the disposal authority.
13. Precautions shall be taken to deal effectively with any vermin or insects on the site (the local authority's Public Health Department will undertake to carry out periodic surveys).
14. ✓ A record shall be kept of types, and quantities of waste deposited, but for normal material the quarterly statement will be acceptable.
15. Any material which will be subsequently reclaimed, to be deposited within the site boundaries for storage in areas, agreed with the waste disposal authority.
16. Any temporary cessation of operations for a period in excess of three months shall be notified to the waste disposal authority.
17. All containers such as 40 gallon drums which could cause large voids, must be crushed before tipping.
