4. Details of our assessment

A Site inspection was undertaken at Griffiths New Lodge site EPR/CB3297ZG on 28 January 2022 by Sally Wakeford and accompanied by Gavin Griffiths and Jake Stephens.

The site is newly permitted, however the operator is established at another permitted site, and understands the requirements of operational and reporting permit conditions.

Pre-operational & Improvement Conditions:

The site does have some pre-operational and improvement conditions:

PO1 *Supporting information in relation to site condition report including baseline data and produced in accordance with “Guidance for applicants H5 Site Condition report – guidance and templates”, will be submitted to Natural Resources Wales for written assessment*

Samples have been taken in January. Please forward the report asap so this Pre-operational condition can be signed off.

PO2 *Installation of embankments and barriers at the locations and to the dimensions as specified in the Noise Impact Assessment and Noise Management Plan. A report confirming the embankments and barriers are in place and to the correct specification will be submitted to Natural Resources Wales for written approval.*

On 08 February 2022 a report was submitted by Jake Stephens regarding the placement of the bunds including photographs of them in situ at the locations. It was noted whilst on site that these noise bunds were in place.

IC1 *The Operator shall undertake noise monitoring at the nearest local receptors including a full noise monitoring survey and assessment meeting the BS4142:2014 standard. Etc*

It was stated during the inspection that this is in progress.

Washplant installation

During the site inspection it was noted that the installation of a washplant is ongoing, and would take several months to complete.

The activity of using a washplant was not submitted and assessed as part of your permit application, therefore this activity has not been included in your permit. You must apply for a variation to the permit to be able to undertake this activity at the site.

We also discussed the fines which are produced in a washplant, and potential outlets for them, as it is worth considering now prior to any potential build up.
