PERMIT

WHEREAS on 30 May 1995 the Isle of Anglesey Borough Council granted to you a Waste Disposal Licence, now to be treated as a Waste Management Licence, Reference Number YMBC/5 relating to Phoenix Metals and Colin Davies Non-Ferrous Metals, Gaerwen Industrial Estate, Gaerwen, Ynys Mon, Gwynedd subject to the conditions set out therein and in any subsequent Modifications.

NOTICE is HEREBY GIVEN that the Environment Agency ("the Agency") modifies the said conditions as follows:-

The following Conditions attached to Waste Management Licence Reference Number YMBC/5 shall be deleted,

Condition Number(s): D.9

and the attached Conditions, Waste Management Licence Reference Number YMBC/5 shall be substituted.

New Condition No: D.9

D.9.1 A record shall be kept of all wastes received and of all materials (wastes and recovered materials) removed from the site. The records shall include the following for each vehicle load of waste/material.

for waste received

- (a) origin of waste
- (b) date received
- (c) quantities in tonnes received and waste type as specified in Condition No: B.1
- (d) nature of the waste (solid, liquid or sludge)

for waste/material removed

- (a) date removed
- (b) quantities in tonnes removed and waste and/or material type
- (c) destination of waste and/or materials removed
- (d) nature of the waste and/or materials (solid, liquid or sludge)

D.9.2 A summary of the information, including nil returns shall be submitted to the Agency, in a format required by the Agency. Summaries shall be for each financial year and shall be submitted to the Agency within one month of the end of each financial year.

Such modification shall take effect on 31 March 1999 at 24.00 hours.
