Site was generally busy at time of inspection. There was a large amount of un-depolluted ELVs stored on site, awaiting processing. There was a large amount of scrap metal stockpiled and also a large amount of baled ELVs. ELVs were being de-polluted in the ELV workshop at the time of inspection.

Following the last site inspection the area where engine blocks are stored was tidier, with all parts stored within containers and the ground was clear of any visible oil contamination.

All areas of site were inspected. No non-compliances were noted.

Site check sheets were viewed at the site office and were in good order.
