The framework for the new building has been erected and work is ongoing to complete the works (see Photo 1). I was informed that the hoped for finish date for the construction of the building is November. Once the building is complete then further concreting works and drainage works will be done. It is hoped that all infrastructure will be completed by April/May 2018.

In the corner of the site between the two buildings the wood processing area has been upgraded (see Photo 2). In this area there is now a new wood treatment process which includes an eddy sifter and shredder to help reduce the wood waste to a size suitable for onward transport to a Wood EfW site.

Total quantities of mixed waste on site were observed to be relatively low. Some mixed waste was observed being stored outside the waste transfer building again but no breach will be recorded due to the effort being made to resolve this, i.e. construction of building.

No issues observed during the site inspection on site.

After leaving site I observed some strange runoff from under the perimeter wall of the site. The below photos 3 and 4 show what was observed. The runoff may be coming from the wood processing area which was located on the opposite side of this section of the perimeter wall. Please investigate and if anything needs to be done to resolve this issue please take action. All waste activities should be contained on the site and all waste must be stored on impermeable surface with sealed drainage. If there is runoff from waste storage/treatment areas then the drainage would not be regarded as sealed.
