Accompanied site inspection undertaken with Dan Harper. Site has now completed the installation of the new office building, which has been in use since October. The old office building is now being used as a staff canteen.

Site has acquired a new dust suppression system, which is also in use. The equipment is a mist-cannon type system attached to a mobile bowser.

The waste wood stockpile has reduced slightly in size and in height. In addition the majority of the inert waste has now been removed from the site. In general at the time of the visit site was clean and tidy.

Following the site inspection regulating officer identified non-compliance with permit conditions, which are detailed below:

C3/ Management - Materials Acceptance (Permit condition 1.2.2, Working Plan 1.5.4)

Management system and operating procedures not being followed as site is in breach of permit condition 1.2.2 and working plan condition 1.5.4 (V 2.1). This is because according to the waste returns submitted by operator to date between January 2014 and September 2014 site has accepted 42,863.09 tonnes of waste. Site is authorised to accept 24,999 tonnes of waste per year only (permit condition 1.2.2). At current rate by end of December 2014 site is likely to accept more than twice the permitted quantity of waste. Working plan condition 1.5.4 briefly states throughput of the site will be to a maximum of 100 tonnes per day and less than 25,000 tonnes per annum.

Operator has submitted an application to vary the existing permit to increase the permitted quantities of waste and extend the permitted area in June 2014. However, the application is still in determination and current permit conditions still stand.


Site has received a **CCS score 3** for non-compliance with permit condition.

General Comments:

Regulating officer has been enquiring about the origin and status of the large stockpile of soil stored outside the permitted area. It was stated previously that the soil is a product and sold by the building supply side of the company to its customers. Previously Dan Harper stated the soil goes through the weighbridge at the waste site and weighbridge details are held at the site office. However, during this visit Dan stated this statement was incorrect as the waste site does not hold any of the information related to the soil stored outside of the permitted area. Officer was advised to contact Tim Harper who will be able to provide the relevant information.
