Mentioned that we had received recent complaints regarding seagulls above and around the site. The complaints had concerned seagulls circling the site at the weekend. It was explained that the bird scaring cannon had been working very successfully and as the seagull problem seemed to have eased at this site the decision was made to temporarily send the bird scarer to the Abergele site to tackle the seagulls there. The bird scarer had only been returned to site in the last couple of days but unfortunately a part of it had been left at the Abergele site. I was informed that they would get the bird scarer operating again as soon as they could. During the walk around site I did not observe any seagulls near the household waste. I did, however, observe a handful perched around the edge of the site and on top of the inert waste piles. Hopefully these birds will be scared off once the bird scarer is in place and operating again. Please pay particular attention to the weekends, especially when the site is not fully staffed.

Some household waste observed outside the shed. The permit states that all waste of this type must be stored (and treated) within a building. Please ensure that the waste is kept within the shed at all times.

It was also observed that quite a bit of dust was being kicked up around the inert waste piles, especially from traffic movement. As I left water was being sprayed around site to try and reduce this dust. Please keep an eye on this and ensure dust abatement procedures are in place in the dry weather.

No breaches on site on this occasion. Overall the site appeared to be in good order.
