Attendance to site and surrounding area due to reported incident (reference 1704007) received on Tuesday the 25th July 2017.

Reporters main complaint was the number of seagulls above the Thorncliffes site and in the surrounding area. The report refers to loud bangs from the cannon although the reporter did not seem to think the bangs were achieving anything as there were still seagulls about. The reporter also mentioned that they had been inundated with flies on the last couple of Saturday and Sundays though also acknowledges there are no flies present at the time of reporting.

Decision was made to attend the area on this occasion to see if seagulls and flies were an issue. The site was checked from Smithy Lane to see if there were any seagulls visible from a distance. No seagulls were observed. The site was then attended. Met Dan Harper on site and informed him of the latest report. No seagulls or flies were observed whilst I was on site.

As I was there in response to the report nothing else was assessed on site.

Overall, there were no issues observed on site.
