The site inspection was undertaken without any prior notification to the site. The visit was undertaken by both Madeleine Starks and Andrew Sowerby. We met Dan Harper, the site manager, on site.

B4 - Infrastructure - Containment of Stored Materials - Permit Condition 3.2.3 - CCS Cat 3

Permit Condition 3.2.3 states that "all liquids in containers, whose emission to water or land could cause pollution shall be provided with secondary containment....". An IBC containing AdBlue was observed on permeable ground at the bottom of the ramp to the upper area of the site. This was highlighted and arrangements were immediately made to move it. AdBlue contains urea which breaks down into ammonia which in turn can have a detrimental effect on water quality. Please ensure that all potentially polluting liquids are provided with secondary containment, i.e within a bunded area. As action was taken during the site inspection no deadlines have been set. As the potential risk to the environment is regarded as low a Cat 3 breach has been applied.

Walked towards the new building on site. The operator explained that the wood processing area has had a few issues since start up, one of these issues being excessive dust which had been observed on cars on neighbouring sites when we arrived. They have adjusted the process and covered parts of the machinery and believe that this will prevent future issues with wood dust. As action has already been taken to address this no breach will be applied. Wood dust needs to be monitored and dealt with to ensure it does not become an issue on and off site.

The new building is well on the way to being completed. At the time of the inspection the roof was on and the walls were being erected. As soon as the building is available Thorncliffes intend to move their general waste operations into the building.

As we left site a faint sewage odour was noticed just to the rear of the commercial and industrial waste building. The odour was highlighted to a site employee who said they would look into it. The source of the odour was likely to be a nearby manhole.

Overall, the site was observed to be tidy and well organised.
