Accompanied on site by Environment Officer Paul Challender. Met Dan Harper who showed us around the permitted area.

Mixed waste was observed to be overflowing out of the building in the corner. Waste was also being shredded outside on the yard. As has been stated before this type of waste and the treatment of it needs to all be stored within a building. Fortunately, Thorncliffes have now received planning permission to build the required building. However, before the building work can start the Local Authority have detailed a number of requirements, i.e. improvements to drainage, installation of boreholes to monitor the adjacent closed landfill etc.

The yard had recently been damped down and as a result there were no issues with dust observed. We were informed on site that the yard can be damped down a number of times in the day if dust is a problem. It is done when needed.

No birds were observed circling the site or on the waste piles on site. The general reduction in bird and dust complaints was discussed and it is hoped this continues. Birds and dust should be easier to control once the planned site improvements are completed. Any future complaints will be passed onto the site for investigation as before.

No other issues observed on site.
