BAE want to use the proving oven to safely dispose of aged chemicals which cannot be safely removed from their glass containers.

The maximum amount of material to be disposed of would be 400g per month. Natural Resources Wales (NRW) have received a complete breakdown of the gases that would be released when the material is heated. None of the gases pose a risk to the environment because the quantities involved are insignificant.

Permit Condition 4.3.5 states

"Where the operator proposes to make a change in the nature or functioning, or an extension of the activities, which may have consequences for the environment and the change is not otherwise the subject of an application for approval under the Regulations or this permit:

- (a) Natural Resources Wales shall be notified at least 14 days before making the change; and*
- (b) the notification shall contain a description of the proposed change in operation."*

NRW have received notification and a description of the proposed operational changes within the time limit.

NRW will allow BAE to dispose of the aged chemicals in the proving oven and will allow them to add waste code **15-01-07 waste glass packaging** to the list of wastes that they may accept at the proving oven.

This permission will be valid for one calendar year from the date of issue, after which time the proposed consolidation of all BAE's permits should be complete. If this is not so BAE should apply to have waste code 15-01-07 added to the list of wastes that can be accepted in Schedule 2 of permit GB3293HT.
