A routine inspection was undertaken on Wednesday 29th March 2017. Present during the inspection was Penny Weaver (CWM) Liane Bacon-Weekes (NRW) and Michael Edwards (NRW). At the time of the inspection, no operational issues were identified. The site was well organised, clean and tidy.

Comments from previous CAR forms dated 29/01/2016

- Oil containers stored outside bund. This was rectified on the day of inspection.
- Update EMS – this has been completed

Observations and recommendation from inspection

EMS

A site specific EMS has now been produced for each site. This is a great improvement and provides the evidence that you are complying with your permit conditions. As discussed, to complete this, please include a site plan which includes, surface and foul drainage (colour coded blue for surface and red for foul), chemical and oil storage, location of waste storage area, location of discharge and sample points, proximity to neighbours and potential areas of contaminated land.

Site Drainage

During the inspection we discussed the drainage system on site and its discharge into the landfill. From your permit I can see that it has been varied to allow the discharge of surface water effluent to the landfill leachate pumping station under a DCWW consent.
