### 4. Details of our assessment

**PERMIT BREACH – TOTAL NITROGEN**

**Part of Permit Assessed - 3 Emissions****E3 - Emissions - Surface water C3 3.1.1, 3.1.2**

Schedule 5 notifications have shown a breach of permit limit for effluent discharge from your facility into to the Afon Erch. The breach in question on this occasion is for total Nitrogen. This breach was sampled on the 10/02/2022.

**Permit condition 3.1 states:**

**3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1 and S3.2**

**3.1.2 The limits given in schedule 3 shall not be exceeded.**

The limit for total Nitrogen is 20mg/l and the value reported was 24.9mg/l. This result is less than 2 times the permitted limit and is therefore in the context of this discharge considered a minor breach.

**The CCS score on this occasion is a CCS 3.**

Please investigate the reason for the permit breach for total Nitrogen and check if this is related to any shutdown procedures and report findings to NRW by the 28<sup>th</sup> March 2022.
