4. Details of our assessment

Annual performance reporting

Condition 4.2.2 of the permit requires a report on the performance of the permitted activities over the previous year to be submitted by the 31 January. This report was received on the 11 February 2022 following a request by NRW. **This has been scored a CCS4 breach of Condition 4.2.2**

Action: Ensure future monitoring returns are submitted in accordance with the permit.

Review of monitoring returns

Condition 3.5.1 requires the operator to undertake monitoring as detailed in Table S.3.1. The operator is not using the solvent tank relating to the emission point and therefore there are no results for 2021. This is consistent with the observations made during a recent visit on 01.02.2022.

Water and energy usage for the permitted area is estimated based on usage across the entire site. 10% of water usage and 25% of energy usage has been attributed to the permitted area. The results are exactly the same as reported for 2021.

Action: Please check the usage reported for 2022.

Waste Returns

Quarterly waste returns were submitted in accordance with condition 4.2.5.
