4. Details of our assessment

This Compliance Assessment Report follows a routine inspection of the site undertaken on 01 February by Regulatory Officers Rebecca Harwood and Paul Challender.

The permitted area (Installation Boundary edged dark blue, Schedule 7 – Site Plan) covers a small area to the north of the site.

The site was clean and tidy with waste being stored in bays with dividing concrete sills separating them. The IBCs within these bays are not bunded, however the permitted area has separate drainage and containment. There was no evidence of any spills. The Operator confirmed that when they bulk up loads for transfer off site they do not mix the waste streams.

The separately bunded flammable area was in good condition and not being used for flammable waste at the time of the inspection.

Although outside of the permitted area the Operator reported that there was a fire on Prince William Avenue on 18 January 2022 adjacent to the site boundary. There was no direct impact to the permitted area, however, some trees adjacent to the entrance and that screen the sites unpermitted area were burnt.

Action: Please forward your internal incident report relating to the fire to NRW by 31.03.2022.

There is a tank for fire water in the centre of the site that holds around 45-50t of water.

Sodium nitrate from Johnson Matthey is held in the tanks to the north east of the site and is covered by a separate hazardous substances consent.

Permit Variation

The Operator has submitted a permit variation to add additional non hazardous waste codes to the permit. They have been asked to review their FPMP based on NRW's guidance [Guidance No. 16 Fire prevention and mitigation plan - waste management \(cyfoethnaturiol.cymru\)](#). Officers discussed the requirements and what needed to be addressed in order for the variation to be duly made.

Improvement Conditions

A noise report was submitted to NRW on 29 October 2021 in respect of Improvement Condition 2. Officers discussed the submission and asked for additional information to be

added to the report.
