Cwm Rhondda Waste Management Site Visit, Williamstown (EPR/WP3797ED) – 19/03/2019

Environment officers Craig Coleman and Claudia Peppicelli attended the Cwm Rhondda Waste Management facility in Williamstown, RCT; on 19/03/2019 in response to an incident report that there was a foul odour emitting from the site, creating uncomfortable living conditions for local residents. We investigated the issue and later met with Susanna, site manager to discuss the complaint. The weather at the time of the visit was fair with no rain, the site was in good condition with no odour emitting from the waste held on site during our visit.

(B3) Site drainage engineering (Clean and Foul):

Whilst onsite the drainage was assessed; the site benefits from an impermeable, concreted surface to prevent any spillage from entering ground water. All surface water on site flows in to an onsite drainage system which has an interceptor. The interceptor is maintained annually.

(B4) Containment of stored materials:

The containment of the waste on site has been an issue previously, with waste being kept at too great a height and exiting the site over the boundary fence. This issue is being well managed by the site staff as the height of the waste is under the limit outlined in the permit.

(D1) Site security:

The site is secured by a boundary fence and an electronic gate which is closed and locked when the site is closed. The fence and the gate appeared to be in good condition.

(F3) Dust/fibres/particulates and litter

The overall condition of the site was clean, there was no litter on the floor and the boundary surrounding the site was mostly clear of litter and debris from site activity.
