

NRW have received queries from the Fire Service about the site. They have reported and are concerned about the amount of waste being stored on the site including tyres and other flammable material. They also have concerns about the security of the site as it allows access to undesirables who may undertake anti-social behaviour. Evidence of fires being started on site could be seen during the visit.

Previous visits and their associated Compliance Assessment Reports (which have been emailed to the permit holder) identified unpermitted 'fly-tipped' waste types on site. This waste is still there and must be removed from site as a priority. The site must also be made secure.

Site security has got worse since our last visit. Whilst the block stone is still in place the gates have now been removed. **This is a breach of your permit and has been recorded as a category 2 non-compliance.**
