Site is non-operational.

Whilst the Local Authority have put boulders at the entrances to the site to prevent vehicular access to the site pedestrian access is still easily found. The gates are missing and there are many breaches in the chain link fencing. This lack of security has led to anti social behaviour at the site including fly-tipping and small fires. **This lack of security is a breach of your permit and has been recorded as a category 2 non compliance.**

NRW are still unable to contact the permit holder despite several letters, site visits, telephone calls and visits to permit holders addresses. NRW have also tried to contact the lease holder of the site to discuss the current situation but have been unsuccessful.

The site must be made secure as a matter of urgency. The waste that has been deposited at the site must also be removed.

Please can a representative of Lorey Metals please contact NRW as a prority to discuss the current situation.
