On arrival to the site I could see that the gates to the upper and the lower yards had been chained shut. Three large boulders had also been placed in front of the gates to the lower yard.

Beyond the gates to the lower yard I could see that a significant quantity of mixed waste including tyres, wood, plastic and construction/demolition materials had been deposited. The deposit of this type of material would not have been permitted under the permit.

Photograph showing unauthorised waste deposit and the boulders that have now been placed at the gate:



Mr Young a consultant representing the permit holder has informed us that the waste was deposited without the permission of the permit holder and after the site had been closed. To ensure that no further unauthorised deposits are made the site has been made secure. The site is no longer operational and it is the operators intention to surrender its permit. The permit holder will send us confirmation of this this week.

Mr Young also confirmed that the waste will be cleared from site to a suitably authorised facility as part of the surrender process. **Please can the permit holder notify us of a date when the waste is due to be cleared.**
