We have received queries from the Fire Service about the site. They have reported and are concerned about the amount of waste being stored on the site including tyres and other flammable material. They also have concerns about the security of the site as it allows access to undesirables who may undertake anti-social behaviour.

During our inspection I could see the waste that was on site the same waste that we referred to on our last inspection and detailed on CAR ID: CAR\_NRW00023775 dated 15/07/17. Following discussions with your consultant Jonny Young, after the last inspection, we were assured that this waste would be removed from site as a priority. It was not.

We were informed that the waste that had been deposited at the site was tipped without the permission of the permit holder after the site had 'closed' and that the site had been made secure so no further tipping could occur. The site is still secure for vehicular access and we do not believe any further tipping has occurred however, there is increasing evidence (broken or bent fence slats etc..) that people are getting into the site. With the added risk of the flammable waste material on site this is unacceptable and a **Category 3 non-compliance** has been recorded.

If unpermitted waste is not removed from the site in an acceptable time period we may consider further enforcement action.

The waste material must be removed from site as a priority. The site must also be made secure. Please can you or a representative of Lorey Metals or the permit holder contact me on 0300 065 4016 to discuss the issue and agree a time scale for the removal of the waste.
