A site inspection was undertaken on Tuesday 1st July 2014. At the time of the inspection the site was operational and accepting scrap metal waste into Unit 8 while the unit next door that is also covered by the permit (A1 Cars) was close to capacity for non-depolluted vehicles. The Technically Competent Manager and Site Manager were not on site.

The following permit breaches were recorded;

Condition 2.3.1 of the permit was breached (Category 2 - Significant) (Ref:B3)

In table 2.3 titles 'Operating Techniques', point 2 states that "All wastes shall be treated on an impermeable surface with a sealed drainage system".

There is currently no drainage system for a large proportion of the site. The unit receiving scrap metal (historically known as Aubrey Metals) has no sealed drainage system and the majority of the yard is unmade ground. There is a proportion of the yard which stores waste and has an impermeable surface but this drains directly to a surface water drain outside of the site. All run-off into this surface water system is considered an non-permitted and illegal discharge to surface waters.

In the A1 Cars unit (previously known as Swansea Recycling Centre) two drains on site appear to be blocked. There is ponding of water at the drain to the rear of the unit.



To become compliant with this condition the site must install a sealed drainage system with all operational areas (where waste is stored/treated) benefiting from impermeable surfaces.

Condition 1.1.3 of the permit was breached (Category 3 - Minor) (Ref:C1)

A non-compliance was recorded against this position as during the inspection all staff present on site had no knowledge or understanding of the Environment Management System (EMS). In a discussion with employees on site there appeared to be confusion over the permit requirements relating to the sealed drainage system.

To become compliant with this condition all staff on site who have responsibilities relating to the permitted activity must have access to the Environment Management System. The EMS should identify all potential risks of pollution and include measures on how those pollutions will be prevented and/or dealt with.

Condition 1.1.1 of the permit was breached (Category 3 - Minor) (Ref:C2)

Our records indicate that there is no up to date Environment Management System (EMS) for the site. It was agreed that an updated copy would be sent to Natural Resources Wales in March 2014. This was not received. A copy of the EMS was not available on site during the inspection. As a result a non-compliance with the above permit condition was recorded.

To become compliant with this condition an up to date Environment Management System must be developed. Copies should be sent through to Natural Resources Wales (details below) and be made available on site.

Condition 2.2.1 of the permit was breached (Category 3 - Minor) (Ref:C3)

During the inspection it was noted that there were a number of non-permitted wastes on site. Condition 2.2.1 (a) relates to Table 2.2a which lists waste types that the site is allowed to accept. While on site undertaking the inspection a significant amount of waste electrical and electronic items (WEEE) were on site. Fridges, TV's, washing machines are not permitted on site. Also, there was a large number of gas cylinders on site which the site is not allowed to accept.



In the A1 Cars unit (formerly Swansea Recycling Centre) there is a quantity of plastic waste. In a previous inspection (12/11/2013) and subsequent discussions it was agreed that all plastic waste would be removed.



To become compliant with this condition all non-permitted wastes must be removed from site and taken to an appropriate facility. Gas cylinders should be stored in a locked cage and it is suggested that they be removed from the site boundary to prevent a potential arson event.

In the future all wastes which are not listed in the permit must be rejected upon arrival at site. Waste acceptance procedures must be included in the EMS.

Condition 3.1.3 of the permit was breached (Category 4 - No Environmental Effect)

(Ref: C4)

Waste oils/liquid containers on site do not have secondary containment. The permit states that all liquids in containers that could cause pollution should have secondary containment. The liquids stored in the de-pollution bay could potentially escape to ground through the back of the shed if an accidental spillage/incident takes place.

To become compliant with this condition secondary containment for all waste oils/liquids must be put in place.

Condition 3.1.1 of the permit was breached (Category 2 - Significant) (Ref: E2)

A large volume of untreated scrap metal is stored on unmade ground. The metal is mixed ferrous and non-ferrous. Rain water run-off from this waste is running directly into unmade ground and thus could potentially enter groundwaters. Wastes include metal filings which the permit states should be stored in a sealed container to prevent ingress of rain water. There are also a number of waste electrical items which should also be stored in a manner which will prevent ingress of rain water.



To become compliant with this condition ALL waste must be removed from areas where the site surface is unmade ground. Consideration should be given to undertaking monitoring (sampling) and remediation works following the removal of waste from these areas.

Condition 4.3.1 of the permit was breached (Category 4 - No Environmental Impact)

(Ref: G4)

Condition 4.3.1 states that Natural Resources Wales (named as 'The Environment Agency' in the permit) shall be notified of any malfunction, breakdown of plant and equipment which leads to a pollution. Natural Resources Wales has made a number of requests to remove waste from areas of the site where there is unmade ground. During the inspection the site foreman (Robert Lorey) stated that there had been equipment/plant failures which prevented the business removing waste from certain areas as requested.

The site has failed to notify Natural Resources Wales of the ongoing problems with plant and a non-compliance with the permit has been recorded.

Directly Applicable Legislation (DAL)

Hazardous Waste Regulations (England and Wales) 2005

At the time of the visit the site was not registered as a hazardous waste producer. If the site produces more than 500kg of hazardous waste a year then a hazardous waste registration must be made. It is suggested that the process of production of hazardous wastes on site be reviewed. This could include a review of all hazardous waste consignment notes which will assist in determining annual volumes of hazardous waste produced on site.

Summary

Requests have been made on previous visits to remove waste from unmade areas, improve drainage and bring the site into compliance. Whereas some waste has been removed from site these there are still significant breaches of the permit. There are a number of non-compliances now on site and a generous amount of time has been given (18 months) to improve issues. This time frame was first set out during an inspection in 2012.

As a result of the continuing non-compliance and failure to improve operations and infrastructure we are now considering taking enforcement action against the site.
