This is the first inspection of the waste transfer station since the permit has transferred from Pembrokeshire County Council and the site has become operational. The inspection consisted of a general overview of the site and a update on the progress of the operation. Liane Bacon and Bryan Cameron were present at the meeting.

Inspection Comments

It was noted during the inspection that there were some teething problems with the plant on site. At that time, the waste was being shredded and then transported to Bryn Posteg Landfill for disposal. This was due to issues with the baler which planned to be rectified within the coming week. At the time of the inspection, there was approximately 200 bales of residual waste being stored outside by the entrance. It is noted in the Environmental Management System that these bales will be stored for no longer than 6 weeks and a methodology and records that evidence this will need to be kept.

As discussed, whilst the site is becoming operational we will undertake an inspection every 6 - 8 weeks and look at specific areas of the permit. During the next inspection I would like to review the Environmental Management System but will contact you prior to this to ensure that I have the most up-to-date copy.
