### General comments

A routine accompanied site inspection carried out with Glyn Morris. A number of waste types are now stored on site both loose on ground and in containers. Large volume of shredded wood waste and inert waste (soil, stone and rubble) stored on site. Operator is hoping to use some of the inert waste on site for construction (track repair) and landscaping purposes (construction of earthen bund around the perimeter of the site). Advised operator that limited amount of uncontaminated inert waste can be used for legitimate construction purposes under a U1 exemption. At the time of the visit site was very muddy.

### Operating techniques

Permit condition 2.3.1 (Table 2.3) briefly states all bulking, treatment and transfer of non-hazardous waste shall be carried out inside a building; storage and treatment within a building or within secure container and on impermeable surface with sealed drainage system. Only **specified waste** can be stored and treated outside. Please ensure you familiarise yourself with the list of the waste codes deemed to be specified waste, which can be found on section 4.4.2 of the permit in order to ensure you store and treat all waste appropriately.

### Environmental management system

At the time of the visit the site EMS could not be checked as it is being updated. Operator aims to complete the new version shortly.

### Duty of Care

Some waste transfer notes were checked and found to be mostly in good order. Occasionally some waste transfer notes was not being completed properly as there are some consignor/driver signatures missing and contains inaccurate EWC code for the waste. Operator will be introducing handheld electronic devices in the new year and anticipates the new system will ensure electronic waste transfer notes are duly completed with correct EWC codes.

### Waste returns

According to the waste returns data site is both receiving and removing waste wood under the EWC code 200138. Regulating officer believes this is not correct as the waste wood is treated on site by shredding the waste. As such the mechanically treated wood waste should then leave the site under the EWC code 191207 and not 200138. Please correct the waste return data and resubmit them by 30<sup>th</sup> January 2015.
