4. Details of our assessment

CAR_NRW0039166 required EnerSys to complete several actions after a failure to monitor discharges to water following an equipment malfunction. Full details are given in that CAR form.

Action G1

Determine cause of intermittent electrical fault & repair as soon as possible. Inform NRW of completion date. Response due by 31st January 2022.

Natural Resources Wales (NRW) received an email on 15th February 2022 informing them that the equipment had been repaired and that replacement of another piece of equipment was necessary. The late reply was because the engineer was not able to visit site before the due date. **EnerSys should have informed NRW as soon as they knew that they would not be able to meet the due date.** EnerSys have purchased a hand pump so that the interceptor can be sampled manually should there be further equipment failures. This demonstrates a proactive approach by EnerSys to future difficulties and is to be commended.

Action completed and can be closed.

Action C1

Train all necessary personnel in the notification requirements given in the permit. Update training records. Send documentary evidence to NRW. Response due by 31st January 2022.

Evidence received by due date.

Action completed and can be closed.

Action G4

Report all breaches of a permit condition to NRW within the time specified in the permit. Response due by 31st January 2022. NRW have assumed that this was actioned upon receipt of the CAR form and have therefore deemed it complete. Action closed.

Action D2

Update procedures to reflect need to notify NRW of any breaches of permit conditions, incidents or accidents. Send documentary evidence to NRW by the due date. Response due by 11th February 2022. The initial response was received on 17th February 2022 and the final one on 25th February 2022.

OPS424 16/02/2022, Environmental Monitoring, has been amended to clarify the procedures for notifying NRW. The Accident Management Plan 2022 was also received.
