4. Details of our assessment

This CAR form relates to review of the submission received via email on 23rd February 2022 of proposed further permanent capping restoration soils placement at Pwllfawatkin landfill under plan titled "Proposed Capping and Restoration April / May 2022 drawing number 479A476"

Further MS teams chat was held on 28th Feb 2022, where FCC confirmed the areas in plan tilted "*Proposed Capping and Restoration April / May 2022 drawing number 479A476*" to receive the 1m layer of restoration soils and associated drainage are those, already covered by permanent plastic membrane previously placed under CQA, at the top of cell 2 and south east flank of cell 4.

Having reviewed the associated documents I am able to provide confirmation that NRW is satisfied with the drawing plan "*Proposed Capping and Restoration April / May 2022 drawing number 479A476*" and the works will be undertaken under the previously accepted CQA plans 497SW 2016/07V1.1 addendum and 497SW 2013/24 Pwllfawarkin Cap CQA plan V1.2 in accordance with the requirements of condition 2.7.4 of the permit.

Please note that the acceptance of the CQA plan for the permanent capping by NRW does not mean the assumptions, design specification, testing regime will be suitable for future developments at the site.
