In the context of the Closed Landfill project this is a desk-based review of your compliance with the permit and the working plan regarding the management of the closure phase of the site and the monitoring plan.

In the late 90's the site was almost completely remediated by the Environment Agency to build a sea wall. I can confirm that you are not required to submit monitoring results as following discussions with my colleagues we are satisfied that there will be no further monitoring requirements. Please note whilst we in principle agree that the application is of a low risk surrender and that attracts a fixed surrender fee of £2,532 we will confirm this once we receive your application and the supporting documents.

In our telephone conversation, I told Mr and Mrs Edwards that I would email them the most up to date information regarding the surrendering of the Permit.
