Accompanied site inspection carried out with operator. Operator currently in the process of installing a picking line with trommel in order to process general/biodegradable waste. Operator is hoping to commission the new equipment by Friday 7 November 2014.

During the inspection the following non-compliance with permit conditions was observed, which is detailed below:

C4/ Management - Storage, Handling, Labelling & Segregation (Table 1.1, Table 4.7bii)

Permit conditions Table 1.1 and Table 4.7bii briefly state that general/biodegradable wastes must be stored in covered shelters or roofed areas. Site is in breach of these conditions as general/biodegradable wastes are being stored in the open. This is because operator requires the storage space in the roofed areas in order to install the new equipment mentioned above.

Operator estimates once the new equipment is commissioned it will take approx. two weeks to clear the backlog.

Site has received a CCS score 3 for non-compliance with permit conditions.

General comment:

It came to our attention that the site deposited some waste at Ty'n-y-Celyn site on 29 July 2014. The Ty'n-y-Celyn site is only authorised to accept waste with EWC code 19 12 12 (soil substitutes only). However, the waste deposited at Ty'n-y-Celyn site from Roadrunner contained trommel fines contaminated with plastic, wood and foam particles. In effect Roadrunner deposited waste at a site, which was not permitted to accept such waste which is an offence.

Operator stated this was done in error and the waste has now been removed from Ty'n-y-Celyn site and taken to a site authorised to accept such waste.
