This site visit was undertaken in response to two notifications made to Natural Resources Wales concerning dust emanating from operations at the waste transfer station.

The visit was undertaken by Paul Moore (Environment officer).

Throughout the visit, no observation was made of dust arising from permitted operations which was having an impact upon neighbouring business units.

Wood processing had been taking place earlier in the day. The officer was informed that the dust suppression system had been operational and it was clear to see as the site surfaces were very wet with water from the misting cannons. The deposits of chipped wood material were below the 3m limit.

A slight wind was blowing in the direction of Multi Packaging Solutions.
