Environment officer attended site as a result of a reported incident (ref 01321142) concerning dust deriving from the site onto a neighbouring business.

Whilst carrying out the investigation, officer arrived on site at 12:45pm.

Upon the visit the investigating officer liaised with ASH personnel Ryan Noons. Environment Officer explained that it had been reported that dust deriving from the site was going onto a neighbouring business. Environment Officer was given the wind information for that day and was shown around site. There was no dust in the air at the time of the visit however I was informed that the site had been screening wood that morning. Ryan assured me that they do not carry out the wood screening activities if the wind is blowing in the direction of the neighbouring businesses.
