This inspection was the result of a notification made to Natural Resources Wales's incident hotline of dust emanating from onsite activities impacting on adjacent neighbouring business units.

An officer attended the complaint and observed dust blowing off site, mixed with water vapour from the misting cannon in operation on the site, blowing per wind direction – towards multi-packaging solutions, beyond site boundary into the neighbouring unit's car park and depositing on parked vehicles.

Although in operation, the misting cannon appeared as though it was not being used effectively, with the wind blowing the water vapour off site. As advised on site consideration should be given to the positioning of this piece of plant, this should be continually monitored whilst the site is operational.

A category 3 non-compliance has been recorded.

F3 – Amenity (Dust, Fibres, Particulates), Permit condition 3.1.1, Compliance Classification Scheme Category 3 Breach.
