This site visit was undertaken in response to two notifications made to Natural Resources Wales concerning dust emanating from operations at the waste transfer station.

The visit was undertaken by Alys Jones (Environment officer).

Throughout the visit, no observation was made of dust arising from permitted operations which would be having an impact upon neighbouring business units.

Wood processing had been taking place earlier in the day, however the officer was informed that the dust suppression system had been operational.

Operatives were working upon the access road of the site near to the site entrance from Redwither Road which was generating a minor amount of dust, this was not linked to permitted operations. Pollution prevention advice was provided.
