An Operator Monitoring Assessment (OMA) audit for emissions monitoring to air from emission point A8 (Kiln) was undertaken by NRW on 15/12/21.

The overall score of 91% is considered very good.

Recommended actions to be completed by 31/08/22 are:

- 1B - Operator to ensure deputies are identified and trained to be competent in any activities regarding CEM maintenance and ongoing quality assurance.
- 4E & 4E - Operator to introduce formal procedure for audit of monitoring & compliance.

Recommendation - Ensure suitable breakdown response is in place for new CEM.
