4. Details of our assessment

At 10:15 on the 11th February 2022 NRW officers Phil Harper, Industry & Waste Regulation Officer and Daniel Grant, Hazardous Waste Officer visited Allen and Smith Metal Recycling. This was an announced inspection.

Emma Smith and Leslie Smith accompanied the inspection.

This was a first-time inspection prior to the permit becoming active. A first inspection form is attached to this CAR form.

No issues were noted on the site.

A1 Site infrastructure

The site has been operating under a T4 exemption. Infrastructural improvements were required to the site drainage before the permit became active. Notably improvements to the site drainage and the installation of storage tanks to contain water from the site interceptor.

At the time of the visit the vehicle depollution building was being constructed. Depollution equipment will be delivered to the site imminently.

C1 Staff Competency and Training

Leslie Smith has registered to undertake the required training to achieve a WAMITAB qualification. Please be reminded that there is a 12-month grace period for new technically competent managers of new permits to achieve WAMITAB status. Please send evidence that you have registered onto the WAMTAB course by email.

D1 Site Security

The site is protected by fencing and lockable gates which were all intact.
