On the 16th October 2015 NRW received a number of odour complaints from local residents in Llanreath area. An NRW Officer attended site and substantiated odours at South Pembrokeshire Hospital. It was confirmed that the odours were coming from the waste site and that doors to the building were open.

F1 - Amenity - Odour - CAT3 - Condition 3.2.1

Odours were detected outside the site boundary

C2 - Management Systems and operating procedures - CAT 3 - Condition 1.1.1

Appropriate measures to prevent odours, as indicated in the Odour Management Plan (OMP) were not implemented. It is stipulated within the sites agreed OMP that the doors to the reception building remain closed to minimise the release of odours to air. During the time of the odour monitoring the doors to the building remained open.
