NRW Environment Officer's Richard PALMER and Ian JAMES completed a site inspection of your site on 11<sup>th</sup> March 2019, to assess compliance with your environmental permit. The weather was mild and dry at the time of inspection and waste scrap metal was being accepted on site. NRW Environment Officers Palmer and James were shown around site by the designated site TCM Ian Lewis. Thank you for taking the time to show us around the site.

The site appeared well managed at the time of inspection and no breaches/issues observed at time of inspection. Waste was being sorted whilst carrying out the inspection and was determined to be within permit limits at time of visit. Roll-on/roll-off skip loads of metal waste arriving and leaving site at time of visit.

Currently, no issues are apparent with the drainage/infrastructure on site, which remains in good condition as per the last site inspection visit. This however should be regularly inspected to ensure that the hardstanding area remains intact and impermeable, under the heavy ware.

Thank you for sending your FPMP document to NRW, I have updated our system with this document and put it forward to the FPMP Assessment Panel for review. NRW will keep you up to date with the progress of the review. Waste stack size, height and accessibility and the designation of a quarantine area in the event of a fire are likely issues to be considered as part of the review.
