4. Details of our assessment

Cathrine Kiely (Senior Waste Regulation Officer) carried out the inspection on the 15th February accompanied by Beth Bentley (Tackling Waste Crime Officer). Kevin Davies (Site Operator) accompanied officers throughout the visit. The weather at the time of the inspection was dry and cloudy but it had been raining previously.

The site was operational during the time of the visit.

The purpose of the inspection was to check compliance with the permit had been achieved following a previous site inspection carried out by Phil Harper (Waste Regulation Officer) on the 8th October 2021.

Non compliance with permit conditions

Operations - Permitted activities 2.1.1

In December 2020 the permit was varied to include the use of a trommel and picking line. However, schedule 1 was also added which stipulates that all treatment will take place within a building.

According to the action stated on CAR_NRW0038896 a building should have been erected by the 7th February 2022. During the inspection there was no building erected and work had not started on construction. You stated that an additional 6 months would be required to erect the building. We discussed the non-compliance with actions generated from the last inspection and that the actions generated from this inspection would be formalised in an EPR (2016) Regulation 36 enforcement notice.

A **category 3 permit breach** with respect to permit condition 2.1.1. "The operator is only authorised to carry out the activities specified in schedule 1 table S1.1 (the "activities")" has been applied.

Action: The treatment of waste must take place within a building by the **5th September 2022**.

F1 Odour

There was no odour detected on site.

F2 Noise

The site was operational and there were no noise issues noted

F4 Pests/birds and scavengers

No vermin on site

F5 Deposits on Road

The ground was very wet underfoot however there was no issue with mud been trailed onto the road.
