4. Details of our assessment

On 15 February 2021 Swansea Drydocks Limited was informed via email that the list of UK Ship Recyclers approved facilities had been updated and Swansea Dry Docks continues to be on the list. The full list of approved facilities can be found here:

The approval expires on 02 July 2025, at which point Swansea Drydocks will have to reapply to be included.

As no ships are currently being dismantled, a site inspection was not carried out, however a desktop audit was undertaken.

Waste Returns:

Submitted waste returns for the last 2 quarters were assessed, although there has been no dismantling occurring recently it was noted that you have reported waste leaving the site.

As discussed, you do not need to report any waste which is not part of the permitted activity, namely the ship dismantling activity. Waste from the repair activity does not need to be reported on the NRW Waste & Materials Facility Returns form, however you should continue to undertake all duty of care paperwork, such as retaining transfer notes.
