INTRODUCTION

The operator of the site is Morris & Co. (Handlers) Limited whose registered office is at Bankwood Lane, New Rossington, Doncaster, South Yorkshire DN11 0PS (**the Operator**).

The Operator has 2 core documents as part of its written management system:

1. Summary of Management System – this document highlights the steps taken to control environmental risks; and
2. Fire Prevention Plan – the purpose of this plan is to identify potential hazards and implement the required mitigation measures to minimise the risk and consequences of a fire occurring on site.

These documents set out the systems that the Regulated Facility has in place and is a working document for staff to refer to.

The Summary of Management System and Fire Prevention Plans are the result of a risk assessment carried out to identify potential hazards arising from the site and any possible pathways and receptors.

Overview of the operation

The Site is regulated by the Environment Agency under Environmental Permit no. EPR/JP3190CL (**the Permit**).

The Permit details the permitted waste types and quantities for the site and all staff should make themselves familiar with it.

- The Permit authorises the holder to operate a Metal Recycling Site and Vehicle Depollution & Dismantling Facility (**Regulated Facility**) at Bankwood Lane (**the Site**). The Site no longer accepts ELV (End of Life Vehicle) waste and therefore this summary relates to the Metal Recycling activities carried on at the Site
- The total quantity of waste that can be accepted on the site is 75,000 tonnes per year.
- Metal recyclables are predominately received loose on articulated or bulk carrier vehicles.
- Loose material, once checked and accepted upon delivery, is stored on the outside yard area in dedicated bays.
- Material following treatment is stored either on the outside yard area in dedicated bays or in a building.
- Treatment of waste is performed on site. The Permit authorises treatment consisting of sorting, separation, grading, baling, shearing, compacting, crushing or cutting of waste into different components for recovery.
- Some of the metals can be directly sold on and therefore no treatment is required.
