I will keep you updated on this issue.

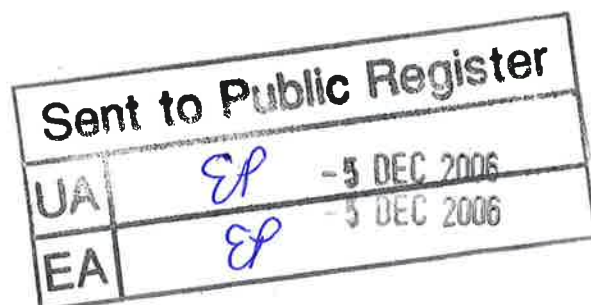
