4. Details of our assessment

The Annual Environmental Review for 2021 was received on 28th February 2022.

The report is accepted.

All emissions to air, water and sewer were within their respective emission limit values (ELV). Maintenance of the air abatement equipment has been improved to ensure that emissions continue to be compliant. Particulate emissions are now reported annually and were compliant when measured in November 2021.

Average fugitive emissions were less than the Statutory Air Quality Standard; $0.012\mu\text{g}/\text{m}^3$ at the boundary fence and $0.03\mu\text{g}/\text{m}^3$ on the canteen roof. These results cannot be compared with previous years (2019, 2020 and part of 2021) due to discrepancies discovered in those readings in 2021. The cause of these discrepancies has now been rectified and is most unlikely to recur.

Problems with sampling from the interceptor, which occurred in Q1 and Q4 2021, have been rectified. A spare pump is now held in stock and a hand pump has been purchased to enable manual sampling in the event of electrical problems. Comprehensive corrective actions have been completed.

Increases in staff numbers and production levels have resulted in increased water use and waste generation. However, a greater proportion of the waste is now sent for recycling.

Energy efficiency is improving year on year, even though total energy use has increased.

EnerSys achieved one of two environmental objectives set for FY21 and have three set for FY22.

One is a corporate objective to reduce energy consumption, the level will be set company-wide.

The changes in environmental management personnel have meant that 2021 has been a difficult year, resulting in some non-compliances due to actions of the previous management. EnerSys have managed these difficulties well and Natural Resources Wales (NRW) are confident that EnerSys will continue with their record of good compliance with permit conditions. NRW value the openness that has been established with this new regime in 2021.
