4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales.

On arrival, site was closed and gates were locked. Unable to perform full site inspection.

General Management (C1)

Under condition 1.1.4 The operator shall comply with the requirements of an approved competence scheme.

Action - please provide confirmation of the above permit requirement to Natural Resource Wales by 31 March 2022.

Records submission (G4)

Condition 4.2.2 states - Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

No waste returns have been submitted to Natural Resources Wales in the lifetime of the permit. This issue has been raised on several previous site inspections. This has been scored as a **category 4 breach** of permit **condition 4.2.2**.

Action - Submit all missing waste returns as required under condition 4.2.2 of the permit to Natural Resource Wales by 31 March 2022.

Natural Resources Wales will also write to you separately with regards to this issue.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
