4. Details of our assessment

Dear Owain,

Thank you for self-reporting a breach of permit condition 1.4 - the volume of discharge shall not exceed **1386m3/day**. NRW appreciates your honesty.

On 13th February 2022 the volume of treated effluent discharged exceeded your permitted limit, being reported as **1431.46m³/day**.

Having checked the weather for that day, an amber warning was in force due to exceptionally heavy rainfall and flooding. Due to the volume of water in the receiving watercourse and the diluted treated effluent, it is unlikely this additional volume would have caused a significant detrimental impact.

Therefore, on this occasion NRW will not be requesting or taking any further action regarding this singular breach.
