Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of environmental permit EPR/WP3132SX referred to in the status log.

A Waste Management Licence (EAWML 37203) was issued in 1999 and permitted an inert landfill and waste transfer station. Under the Pollution Prevention and Control (England and Wales) Regulations 2001, Inert Waste Landfills required permitting under the regulations and a new PPC Permit was issued in 2007. The permit, had reference WP3132SX. The PPC Permit superseded the existing Waste Management Licence to the extent of the activities covered by the PPC Regulations. The waste transfer station was not included in the PPC permit.

Under the Environmental Permitting Regulations 2007, the status of Inert Waste Landfills changed from that of an "Installation" to one of a "Waste Facility". In 2010 the PPC Permit was transferred to the current Operator. The reference of the permit was changed to EPR/FP3590LV.

An EA variation has now been carried out to add activities, waste types and quantities for the waste transfer station to the existing permit.

The status log of a permit sets out the permitting history, including any changes to the permit reference number.
