Comments

Inspection pre-arranged so that paperwork could be checked on site. Unfortunately upon arrival officers were informed that due to illness Joanne Bennett was unable to attend. As Joanne generally deals with the paperwork it was requested that the paperwork be checked during the next inspection instead.

Area A was checked. Of the ELVs checked most looked to have been fully depolluted. However, whilst airbags had been removed from nearly every ELV checked, a couple were noticed still be in cars.

The drainage hole on Area A was observed to be completely covered during this inspection. No signs of oil on the hardstanding in the areas checked.

Area B was then checked. A contractor was on site at the time of the inspection. He has been brought in to build a bunded area next to the depollution area, to finish off some concreting work and build a sill around area B. This work was due to start the following day once he had completed some work that the landlord had requested be done. Overall area B looked to be relatively clean. There is an issue with the crane as it was leaking oil. There was, however, no risk to the environment from this as the crane was parked on area B which is fully concreted with sealed drainage. Sawdust was being used to absorb any leaking oil that got on the concrete and the fitter was due on Monday to repair it. Until that time the crane would not be used.

Overall the site was in reasonable condition and there was space on area B to store any ELVs that might be brought to site. No ELVs were observed being stored outside the permitted area.

Now that all major changes on site have been made the Environment Management System needs to be updated to ensure it accurately represents the site and the operations carried out. During my next inspection we can discuss the changes that need to be made and agree a deadline by which it should be complete.
