Officers Jonathan LEE and Chris BURGE in attendance of Energy Pyrolysis Limited, Penyrheol Sidings, Caerphilly to complete a compliance inspection of the environmental permit EPR-AB3391HB. The permit is for a Standard Rules SR2008 No25 – Clinical waste & healthcare waste treatment and transfer station. Weather was mild with light rain at the time of the inspection. No staff attended the inspection, access to the site building was granted by the landowner.

Given the non-operational status of the facility and a recent application to surrender the permit, the inspection was made to complete a final inspection of the permitted area.

### **Inspection**

There was no wastes present within the permitted area at the time of the inspection. There was no machinery present within the permitted area. Site activities had clearly ceased.

There was a small quantity of cardboard packaging present on site.

The impermeable surface present within the site building was in good condition. No risk or evidence of an ongoing pollution to ground or water was identifiable at the time of the inspection.

The site was secure, with locked doors preventing unauthorised access.

### **Summary**

No compliance breaches were identified during the inspection.
