The above submissions have been reviewed and assessed with one issue identified. See below.

Comments;

Whilst monitoring was carried out in-line with permitting requirements and all within ELVs there was a delay to Q1, 2 and 3 reporting. This is recorded as a **C4 breach**.

Sewer 1 non-reporting for Acetone and Dichloromethane are covered in previous CAR NRW0037034.

Air1 form to be changed from BS EN 13526:2002 to BS EN 12619:2013. Confirming here that monitoring is carried out to the latter, updated standard.
