Site inspection with Nigel Broxton EHS manager and Mark Lloyd-Jones operations manager.

Discussion regarding feedstock. Fuel is now virgin wood shavings and 'whole tree' shred. There are no plans to use biomass waste in the fuel feedstock.

This is part of a drive to reduce ash and waste arisings from operations.

Discussion regarding training and awareness of permit. Nigel Broxton provides staff training.

Discussion regarding operations. There will be a maintenance outage from the 6th April through to the 13th April. Anticipated that MCERTS emission testing will be conducted thereafter on the 21st April and will be submitted to NRW by the 30th April.

Discussion regarding 'learning from experience' from Ruthin site bag filter issue.

Kinmel Site have taken on board learning from this and monitor bag filter pressures to ensure early warning signs are picked up.

Bag filter pressures monitored by control room staff/operators.

Ringelmanns test is performed and recorded by control room staff/operators.

Nigel Broxton will review and re issue the plant preventative maintenance schedule chapter of environment management system to reflect lessons learnt.- within 3 months of the inspection date

Site tour viewing all areas of plant including feedstock area. Clean feedstock observed. Top of photograph, virgin wood shavings. Bottom whole tree shred.
